**NOTIFICATION**

**F. No. 17/1/2016-CS/ 96 :-** In exercise of the powers conferred by Sub-Section (1) of the Section 40 of the National Food Security Act, 2013,(No.20 of 2013), the Administrator, Union Territory of Lakshadweep hereby makes the following rules to amend the Lakshadweep Food Security Rules,2016, namely:-


- (i) These rules may be called the Lakshadweep Food Security (Amendment) Rules,2016  
(ii) They shall come into force from the date of their publication in the official Gazette.
- In rule 10 of the Lakshadweep Food Security Rules ,2016 the following shall be substituted namely:

The constitution of the State Food Commission shall be following:

- (i) Chairman - Advisor to Hon'ble Administrator (IAS)
- (ii) Member Secretary - Collector/Secretary
- (iii) Members -
  1. Director, Social Welfare,UT of Lakshadweep.
  2. Director, Medical & Health Service, UT of Lakshadweep.
  3. Director, Woman & Child Development, UT of Lakshadweep.
  - 4.Smt.Fathima Augothi Bidaruage,Member District Panchayath, Lakshadweep.
  5. Smt. Raziya Beegum, Former Chairperson,Village (Dweep) Panchayath, Kavaratti.

The term of the State Food Commission shall be for a period of One year or till further orders whichever is earlier.
